Statement 1 shows the reduction of tax basis on a per share per day basis.

Amounts in excess of earnings and profits reduce the shareholder's basis in its shares to the extent of basis.

Internal Revenue Code §301(c)(2) provides that the portion of the common stock distribution which is not a dividend shall be applied against and reduce the adjusted basis of the stock.
